RESPONSIBLE INTERNET USE

Rules for Students

The school computer system provides Internet access to students and staff. This Responsible Internet Use statement will help protect students, staff and the school by clearly stating what is acceptable and what is not.

- Users must access the Internet only via the user's authorized account and password, which must not be given to any other person.
- School computer and Internet use must be appropriate to the student's educational programme of study.
- Copyright and intellectual property rights must be respected.
- Users are responsible for the e-mails they send and for contacts made.
- E-mails should be written carefully and politely. As messages may be forwarded, e-mail is best regarded as public property.
- Anonymous messages and chain letters must not be sent.
- The use of public chat rooms is not allowed.
- The school ICT system may not be used for private purposes, unless appropriate authorization has been given.
- Use for personal financial gain, gambling, advertising or any activity which the School deems offensive is forbidden.
- The security for ICT systems must not be compromised.

The school will exercise its right by electronic means to monitor the use of the school's computer systems, including the monitoring of websites, the interception of e-mails and the detection of inappropriate materials in circumstances where it is believed unauthorized use of the school's computer system is or may be taking place, or the system is or may be being used for criminal purposes or for storing text or imagery which is unauthorised or unlawful.

Those responsible for the unauthorized use of the school's computers will be subject to the full disciplinary sanctions available to the Head Teacher and Governors, up to and including fixed-term or permanent exclusion.
